## Introduction

The international Biosafety agenda will be very busy during the Italian Presidency of the Council of the EU.

We need to prepare EU participation and positions for Cartagena Protocol COP/MOP 7.

The most important issues addressed by Cartagena Protocol on Biosafety COP-MOP 7 agenda are:

- Handling, transport, packaging and identification of living modified organisms (Article 18).
- Nagoya Kuala Lumpur Supplementary Protocol on Liability and Redress
- Risk assessment and risk management (Articles 15 and 16).
- Socio-economic considerations (Article 26).
- Monitoring and reporting (Article 33).
- Assessment and review of the effectiveness of the Protocol (Article 35).
- Unintentional transboundary movements and emergency measures (Article 17).
- Contained use of living modified organisms (Article 6).
