Breve descrizione del progetto	<p>The project will be implemented in three Natura 2000 sites, located in the Province of Trapani, specially inside the protected areas of Natural Reserve that consists of: the Stagnone's lagoon of Marsala, the Saltpans of Trapani and Paceco. In this area there are coastal zones of high nature value which are seriously threatens by progressive human pressure, which intimidates the local biodiversity. Therefore the project will implement a comparative analysis of the Conservation Status of the habitat of Paceco, Trapani and Marsala Natural Reserves with the aim to identify the anthropic effects that deteriorate the sites, to define the guidelines to reduce or minimize them and finally to realize the conservation actions to will permit to improve the ecosystem and to protect the species of Community interest.</p>
