> Supplemental Contribution Amendment to the Administration Agreement between the Republic of Italy, acting through its Ministry for the Environment, Land and Sea, and the International Bank for Reconstruction and Development and the International Development Association concerning the Multi-Donor Trust Fund for Communication for Climate Change (TF No. 071191)

Dear Dr. La Camera:

- We refer to the Administration Agreement between the Republic of Italy, acting through the Ministry for the Environment, Land and Sea (the "Donor") and the International Bank for Reconstruction and Development ("IBRD") and the International Development Association ("IDA") (collectively, the "Bank") regarding the Multi-Donor Trust Fund for Communication for Climate Change (TF071191) (the "Trust Fund") effective January 15, 2009, as amended (the "Administration Agreement").
- We are pleased to acknowledge, on behalf of the Bank, the intention of the Donor to 2. make a supplemental contribution to the Trust Fund in the amount of three million Euro (EUR 3,000,000) (the "Supplemental Contribution").
- 3. The Donor shall deposit the Contribution in the currency specified in paragraph 2 above into such bank account designated by the Bank promptly following effectiveness of this Amendment and submission of a payment request by the Bank.
- When making a deposit, the Donor shall instruct its bank to include in its deposit details information (remittance advice) field of its SWIFT deposit message, information indicating: the amount deposited, that the deposit is made by the Donor for the Multi-Donor Trust Fund for Communication for Climate Change (TF071191), and the date of the deposit (the "Deposit Instructions"). In addition, the Donor shall provide a copy of the Deposit Instructions to the Bank's Accounting Trust Funds Division by e-mail sent to tfremitadvice@worldbank.org or by fax sent to (202) 614-1315.

- 5. All other terms of the Administration Agreement shall remain the same.
- 6. The Bank will disclose this Amendment and related information on the Trust Fund in accordance with the World Bank Policy on Access to Information. By entering into this Amendment, the Donor consents to disclosure of this Amendment and related information on the Trust Fund.
- 7. We propose that this letter shall constitute an amendment to the Administration Agreement between the Bank and the Donor. Please confirm your acceptance to the foregoing, on behalf of the Donor, by signing and dating the two originals, retaining one original for your records and returning the other original to the Bank. Upon receipt by the Bank of the original Amendment countersigned by you, this Amendment will become effective as of the date of the countersignature.
