Following the Technical Arrangement (TA) signed in Rome on 29<sup>th</sup> of March 2018, between the Ministry for the Environment, Land and Sea of the Republic of Italy (IMELS) and The Jordan Renewable Energy and Energy Efficiency Fund (JREEEF) under MEMR the Signatories agree to implement the following medium terms Work Plan of Activities.

## Objectives

Following Article 1 of the TA, and taking into account the indications provided by the Nationally Determined Contributions (NDC) that the Hashemite Kingdom of Jordan has submitted to the UNFCCC in 2017, the objectives of the present medium term Work Plan of Activities (WP) is to identify and select activities and projects, which correspond to the general objectives of the TA.

The intention is to make a substantial contribution to the implementation of both adaptation and mitigation actions to climate change, to proper address and manage the current and future impacts in The Hashemite Kingdom of Jordan related to energy issues

## Priority Areas that have been selected

Following Article 4 of the TA, and taking into account, this WP aims to focus, in this first step, on the following areas of interest:

1. Promotion/development of initiatives in the field of renewable energy and energy efficiency to achieve the target established by the Hashemite Kingdom of Jordan mainly in sectors; Households, Public Schools, Hospitals, Industrial and Tourism sector .
2. Provide JREEEF with the necessary technical support to expand its capacity in terms of financing and commercial aspects, implementing projects, international networking, exchange/transfer knowledge and expertise.
3. Create more Awareness about the Energy Efficiency and Renewable Energy in Jordan.
4. Promote and expose JREEEF/MEMR to the new RE & EE technology, with focus on Italian technologies and services, to support achieving Jordan's goals and objectives.

Based on article 2 of the TA, the above activities will be implemented through the following measures, (for example) by:

- transfer of scientific and technical knowledge and experience;
- Implementation of joint demonstration projects.
- Technical assistance and awareness raising campaigns, Joint organization of workshops, seminars or other meetings.



Projects' proposal, based on the present Work Plan, will be submitted for their approval to the JC.

To facilitate the financial/technical management of the TA and the common participation of the Parties to international meetings, a dedicated *Implementation Project* will provide the needed resources (see *Implementation Project* proposal in annex).

### **Entry into force**

This Work Plan will come into force after signature of the Parties and shall remain valid for a period of 24 months.

Any amendment to this Work Plan will be adopted by the JC.

This Work Plan is agreed and signed in Rome on 26<sup>th</sup> of June 2018.
