# ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING

on

### COOPERATION IN THE FIELD OF CLIMATE CHANGE VULNERABILITY, RISK ASSESSMENT, ADAPTATION AND MITIGATION

between

## THE MINISTRY FOR THE ENVIRONMENT, LAND AND SEA OF THE ITALIAN REPUBLIC

and

THE GOVERNMENT OF THE REPUBLIC OF ZAMBIA, ACTING THROUGH THE MINISTRY OF NATIONAL DEVELOPMENT PLANNING

WHEREAS the Ministry for the Environment, Land and Sea of the Italian Republic and the Government of the Republic of Zambia, acting through the Ministry of National Development Planning, hereafter referred to as "the Signatories", have entered into a Memorandum of Understanding on cooperation in the field of climate change, vulnerability, risk assessment, adaptation and mitigation.

**WHEREAS** the Signatories agree with the goals and provisions of the Memorandum of Understanding.

**NOW THEREFORE** the Signatories have agreed to make the following addition to the Memorandum of Understanding:

#### Article 1

#### Means of implementation

- 1.1 The Ministry for the Environment, Land and Sea of the Italian Republic will cofinance the implementation of the projects and activities under this Memorandum of Understanding in an amount not exceeding EUR 2.000.000,00 (TWO million Euros).
- 1.2 The contribution from the Government of the Republic of Zambia, acting through the Ministry of National Development Planning, will be decided at a later stage, after consultation with the Minister of Finance, and notified to the other Signatory during the first meeting of the Joint Committee.
- 1.3 The Signatories will jointly submit project proposals to various multilateral organizations (*inter alia* the European Commission, the International Financial Institutions, the United Nations organization, the World Bank Group), in order to assist the Republic of Zambia to fulfill its commitments under the UNFCCC and its instruments.
- 1.4 Wherever there is a need to increase the global amount set in Article 1.1., the Ministry for the Environment, Land and Sea of the Italian Republic may decide to grant additional financing. Should it take such a decision, the Ministry for the Environment, Land and Sea of the Italian Republic will inform the Government of the Republic of Zambia, acting through the Ministry of National Development Planning about the additional amount provided, in the occasion of the Joint Committee. Funds will be issued according to the same terms and conditions set out in the Financial Agreement.

#### Article 2

#### **General Provisions**

- 2.1 The present Addendum to the Memorandum of Understanding shall enter into force upon signature by Signatories and remain in effect until such time as the Memorandum of Understanding expires, is terminated, extended or amended.
- 2.2 All the terms and conditions and the objectives of the Signatories laid down in the Memorandum of Understanding shall remain in full force unless modified by mutual consent of the Signatories by this Amendment.
- 2.3 The presents Addendum will become an integral part of the original MOU.
